# **Paulding Retired Educators Association Bylaws**

## Article I – Name

The name of this organization shall be Paulding Retired Educators Association, here to referred to as PREA.

## Article II – Objectives

The Objectives of PREA are the following:

- A. To cooperate with the Georgia Retired Educators Association.
- B. To cooperate with the NREA Division of the American Association of Retired Persons by promoting Membership and Legislation.
- C. To maintain and improve social, educational, economic, and recreational welfare and status of the retired educators in the local community, state, and nation.
- D. To gather and disseminate information of value to members.
- E. To encourage better fellowship among retired educators.
- F. To present the image of aging as one of dignity, independence, and purpose.
- G. To encourage active educators to prepare for retirement.
- H. To work legislatively to improve retirement benefits of Georgia retired educators.

## Article III – Governance

The PREA shall be governed by its Bylaws.

## Article IV – Affiliation

The PREA shall be affiliated with the Georgia Retired Educators Association and the American Association of Retired Persons (AARP).

## Article V – Membership

### Section 1.

Active - Membership shall be open to any retired or former educator or Administrator who has been employed by any educational institution in the field of education, or who receives a monthly benefit check from the Teachers Retirement System of Georgia.

### Section 2.

Associative - Associate Membership shall be open to any active teacher or other persons interested in the work of the Association and approved for membership by the Executive Committee. An associate member shall have membership rights and privileges, except the right to vote, hold office, or to represent

PREA.

### Section 3.

An Emeritus Member of PREA is a member in good standing that has reached the age of 90. At this time the designated member will no longer pay annual membership dues to the PREA organization. He/She will be informed of this by the PREA President or other PREA officer.

## Article VI - Finance

### Section 1.

Fiscal Year - The fiscal year of PREA shall correspond with that of the Georgia Retired Educators Association and shall begin July 1 and end June 30.

### Section 2. Dues:

- A. Amount of dues - The amount of dues of active, associate, and emeritus members shall be determined by the Executive Committee.
- B. Payment of dues –
  - (i) Continuing members - Dues of all continuing members are payable to the unit treasurer within a three month period of July 1.
  - (ii) New members - Dues of new members received by treasurer within three months of the end of the fiscal year shall be credited to the following fiscal year.

- (iii) Newly retired educators shall receive free PREA membership for first year of retirement provided they join GREA.
- (iv) Emeritus members (Age 90 and over) shall receive free PREA membership.

Section 3. Finances:

The unit shall provide for such audit and control of its finances as are necessary for their complete accounting and safe keeping.

Article VII- Officers: Duties

Section 1.

Officers of PREA shall be President, President-elect, (who shall succeed to the presidency), Recording Secretary, Treasurer, and Immediate Past President.

Section 2. Members of the Executive Committee shall be PREA officers and chairpersons of the standing committees.

All officers shall be GREA members.

Section 3. Election of PREA officers:

- A. All PREA officers shall be elected for a two-year term.
- B. The President, after serving as President, shall serve as Immediate Past President
- C. The Nominations Committee shall present nominated officers to the PREA members for election. The Nominations Committee will present the names in March of the second year of the President's term.

Section 4. Duties of Officers:

- A. The President shall:
  - (i) Preside at all general meetings and meetings of the Executive Committee.
  - (ii) Appoint the Committee chairmen and members of the committees, while serving as an ex-official member of all committees.
  - (iii) Call regular and special meetings of the Executive Committee.
  - (iv) Make recommendations to the Executive Committee for programs of action.
- B. The President-elect shall:
  - (i) Become President when the Presidency becomes vacant.
  - (ii) Assist the President in the execution of the duties of the Presidency and perform other duties as may be delegated by the President.
  - (iii) Serve as chairman of the Finance Committee.
- C. The Secretary shall:
  - (i) Record and keep a permanent file of minutes of the general meetings and of the Executive Committee meetings.
  - (ii) Be responsible for correspondence including cards recognizing donations
- D. The Treasurer shall:
  - (i) Be responsible for collecting and recording receipts of all dues and other monies.
  - (ii) Be responsible for paying any bills.
  - (iii) Be responsible for keeping a proper set of books.
- E. Immediate Past President shall:
  - (i) Serve as advisor to the President and Executive committee.
  - (ii) Serve as chairman of the Nominating Committee.
  - (iii) Serve as Chairman of Membership committee.

Article VIII - Executive Committee

Section 1. Membership:

The Executive Committee shall include the officers and chairmen of the standing committees

Section 2. Duties:

The Executive Committee shall

- A. Carry on the business of the unit.
- B. Have the general power to administer the unit's affairs between meetings and shall report its actions to the members

Section 3. Meetings:

The Executive Committee shall meet at least twice a year. Special meetings will be held as needed.

Article IX – Committees

Section 1: Committees shall be:

A. Standing Committees --There shall be unit standing committees as follows:

- (i) Nomination
- (ii) Membership and Necrology
- (iii) Program
- (iv) Legislative
- (v) Handbook
- (vi) Retirement
- (vii) Inspiration
- (viii) Public Relations
- (ix) Finance
- (x) Scholarship
- (xi) Newsletter and Website
- (xii) Scrapbook
- (xiii) Memorial
- (xiv) Humanitarian Projects

B. Additional Committees – There shall be additional standing and special committees when considered necessary to carry on the work of the unit.

Section 2: Duties of the committees:

- A. Nominations -- This committee shall consist of a chairman and two other members. This committee shall present names of persons for President-Elect, Secretary, and Treasurer to the members of PREA.
- B. Membership and Necrology -- This committee shall consist of a chairman and no more than four members. This committee is responsible for recruiting, reporting and retaining PREA and GREA members. This committee shall contact the Paulding County School Superintendent's office for the current list of retirees. This committee shall keep an updated list of all potential members. This committee shall report deaths of local members to the GREA office. This committee shall present an Honor Book to the appropriate local library upon the death of a PREA Member.
- C. Program -- This committee shall consist of a chairman and no more than three members. This committee shall be responsible for planning the year's programs. This committee shall notify and/or check with the person(s) preparing the program.
- D. Legislative -- This committee shall consist of a chairman and no more than three members. This committee shall keep the PREA members well informed about the State legislative program.
- E. Handbook -- This committee shall consist of the Executive Committee and a chairman from this group appointed by the President of PREA. This committee shall be responsible for compiling, editing, printing, or emailing the handbook to members prior to the November meeting.
- F. Retirement -- This committee shall consist of a chairman and no more than three members. This committee shall be involved in the county's Retirees Celebration.
- G. Inspiration -- This committee shall consist of a chairman and no more than three members. This committee will be responsible for the inspiration at each meeting.

- H. Publicity -- This committee shall consist of a chairman and no more than three members. This committee shall publish notices of meetings in the Dallas New Era and the Paulding Neighbor. This committee shall publish an article each month.
- I. Finance -- This committee shall consist of a chairman (the PREA President-elect) and no more than three members. This committee shall prepare a yearly budget for the unit.
- J. Scholarship-- This committee shall consist of a chairman and 6 to 8 PREA members. This committee shall be responsible for preparing, distributing, and collecting all application forms; responsible for selecting the recipient(s) based on published requirements; responsible for setting amounts and suggesting the means for raising needed funds.
- K. Newsletter - Website -- This committee shall consist of an editor and members as needed to compile, edit, and print a newsletter to be mailed to PREA members. This committee will also maintain the website for the purpose of keeping the membership informed.
- L. Scrapbook -- This committee shall consist of a chairman and one other member. They will construct a one two-sided page for the GREA Scrapbook. It will follow the criteria set forth by GREA and will be sent to the GREA Archives and History Committee by June 1.
- M. Memorial – This committee shall consist of a chairman and other members. This committee shall honor those members who had passed away during the year.
- N. Humanitarian Projects: This committee shall consist of a chairman who assists the President in raising money to support the State President’s Humanitarian Project.

Article X -- Meetings and Quorum

Regular meetings of the unit shall be held in September, November, January, and March, in accordance with the school calendar. The regular meetings are held on the second Tuesday of the above listed months. The April meeting, Cluster Meeting, (which counts as a regular meeting), shall be held on the 1st Thursday of April at announced location, usually the Cherokee Country Club in Cedartown, GA. The date and location of the May meeting, The Annual Retirement Celebration, will be determined by the PREA Executive Committee and announced to the membership (Note: If different the membership shall be notified by newsletter or by phone call). Those members present shall represent a quorum.

Article XI – Amendments

These Bylaws may be amended at the Executive Committee meeting by a vote of 2/3 of the members present. These amendments will be presented and discussed at the following regular PREA meeting.

Article XII -- Rules of Order

The revised version of Robert’s Rule of Order shall govern the meetings in all cases in which they are applicable, and in which they are not inconsistent with the Bylaws of the Paulding Retired Educators Association {Revisions approved by the PREA Executive Committee.}

\*The Telephoning Committee was removed from the Committee List when PREA agreed to do the Phone Tree method of keeping PREA Members informed of meetings and other pertinent information. The decision was made by and approved by the membership and the Executive Committee.

\*The Scholarship Committee was formed and announced to the PREA membership. This Committee will continue to follow the rules set forth in the ‘Duties of Committees on page 12 of the Bylaws.

Revisions approved by the PREA Executive Committee July 21, 2009

\*Article V – Membership Section 1 – remove (PREA membership-first year of retirement is free)

\*Article VI – Section 2B (iii) to read “Newly retired educators shall receive free PREA membership for the first year of retirement provided they join GREA.”

These changes were presented to the membership at regular meeting Sept. 8, 2009.

\*The Memorial Committee was formed and announced to the PREA membership. This committee will continue to follow the guidelines set up to honor those PREA members who have passed away.

\*The PREA Executive Board voted on August 6, 2015, to give a \$200 honorarium to the president to assist with expenses for the GREA State Convention. If this person cannot attend, the money would go to the president-elect. If neither can attend the money would not go to anyone else.

\*The Executive Committee voted that beginning 2018 the PREA Past President will assume the roll as Membership Chairperson for their term as Past President.
